7/03/03: Clean out sand with air to 3684'. Blow well.

7/07/03: Well shut in over weekend. SITP = 255 psi. Blow well down. Clean out with air.

7/08/03: Unload well. Recovered load. Land tubing at 3685', SN one joint from bottom. Release Rig.

7/09/03 through 7/30/03: Let well build pressure. Max SITP and SICP = 525 psi. Used swabbing unit to swab well. Use compressor to get well to unload water. Tested well on 7/21 - 40 mcf/d.
