7/28/03 drilled 6 3/4" hole and ran 4 1/2", J-55, 10.5# LTC casing and landed @ 2132.90' KB. KB = 5'0"

Ran centralizers on the bottom 3 joints including shoe joint, and ran 2 turbulizers at 7' below the Ojo and the 1st joint into the Ojo. Cement: 10 bbls of 10.5# scavenger Class B with 2% Sodium Metasilicate, .25#/sk Cello Flake, 3 ppsk Gilsonite. Lead with 227 sks 12.5# Class B Cement, with 2% Sodium Metasilicate, .25#/sk Cello Flake, 3 pps Gilsonite yield 2.09. Tail with 60 sks 14.5# Class B cement with 4% gel, 2% CaCl₂, .25#/sk Cello Flake, yild 1.55. Thel followed with 34 bls of displacement. Pressure to 900# on pump, bump plug @ 1000#, plug held. No cement returns to surface. Will run CBL with GSL at a later date.
