990' FSL & 990' FEL, Section 20, T16N, R6W

McKinley County, NM

9/5/2002: Rig up JC Well Service. Trip in with 2 3/8" tubing. Tag PBD at 784'. Roll hole with water. Mix and spot 16 sack bottom plug at 782'. Trip out tubing and WOC. Trip in and tag plug at 607'. Casing failed pressure test. Perforate squeeze holes at 100'. Trip in tubing to 160' Mix and pump 35 sacks cement. Closed casing valve and squeezed cement to surface up backside. Had cement to surface in and out of casing. Trip out tubing. Rigged down. Class B cement was used.

Installed abandonment marker and backfilled pit. Cleaned up location.
