Pumped pre-flush- 20 bbls FW & gel/ 10 bbls w/GD. **Lead** w/450 sx (1175cf - 209 bbls) type G cement w/3 % D-79, .2% D-46, & .25 #/sx D-29. **Tailed** w/100 sx (126 cf - 23 bbls) 50/50 POZ Standard cement w/30#/sx D-048, 2% BWOB D-020, .1% BWOB b-046, 5 #/sx D-024, & 1% BW. Dropped plug and displaced w/134 bbls FW. Bumped plug to 1500 psi. Plug down & holding @ 4:30 am on 8/15/06. Circ. 90 bbls cement to surface. RD, & release cement crew. ND BOPE. RD RR on 8/15/06.
