On 6/3/2003 work comenced to downhole commingle the above referenced well. The model "R" packer was removed from the wellbore. The well was flowed to a laydown tank to clean up wellbore. A production string of 2-3/8" tubing was set in well with expendable check on bottom, 2' pup joint, 1.78" "R" nipple, and 251 jts tubing. Tubing was landed overall at 7956' with "R" nipple at 7954'. The well was then turned to sales as a downhole commingled Dakota/Mesa Verde.
