XTO Energy Inc. intends to squeeze cement on the above mentioned well as follows:

- 1) MIRU WL truck. RIH w/3-1/8" csg gun with 2 JSPF (0.48" dia, 2 holes). POH w/csg gun. RDMO WL truck.
- 2) TIH w/5-1/2" CIGR and approx 203 joints of 2-3/8" tbq. Set CIGR @ approx 6230'.
- 3) MIRU cmt crew. Pump 85 sx Premium Lite High Strength cmt w/2.0% KCl, 0.2% CD32, 0.5% FL52 & 1/4 pps Celloflake (12.5 ppg & 2.01 cuft/sx). Flush cmt w/1050 gallons of 2% KCl water.
- 4) Once cmt is pumped away, PU 200' and reverse out remaining cmt from tbq until fluid is clean.
- 5) TOH w/2-3/8" tbq and squeeze tool.
- 6) Allow cmt to set for a minimum of 24 hours.
