We wish to retain the well-bore because we feel there could be up-hole potential in the Mesa Verde formation.

The upper most perforation at 6,870' will be isolated by the placement of a cement retainer at 6,850' and loading the casing with inhibited packer fluid and pressure testing the casing to 500 psig for 30 minutes. We would like to have the well TA'd by September 1, 2001.
