Cement with 600 sks 65/35 Class G, 6% bentonite, 2% CaCl2, 10#/sk gilsonite, 1/2#/sk flocele tailed by 125 sks Class G, 5#/sk gilsonite, 1/4#/sk flocele (1131 cu.ft.). Plug down @ 8:30 pm on 09/15/06. Circulate 66 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
