TD reached 8/29/06. RIH w/underreamer & UR'd from 3295' - 3534'. R & R'd to c/o. Started natural & energized surges to CO. RR'd for 14 days. 9/16/06 RIH w/pre-perf'd 5-1/2" 15.5# J-55 casing as liner & set @ 3534' w/TOL @ 3247'. Perfs from 3339'-3343', 3352'-3357' 3381'-3385', 3405'-3424', 3424'-3444' = 52' w/ 4spf = 208 holes. RIH w/99 jts 3 1/2" 6.5# J-55 tubing and set @ 3424'. ND BOP. RD & released rig 9/15/06.
