Condition hole w/good returns to surface. POOH w/bit. PU under reamer. TIH w/under ream 6- 1/4" hole out to 9-1/2". Underreamed from 3414' - 3476', then from 3476'-3620'. RIH w/5-1/2", 15.5#, & J-55 LT&C casing (liner) & set @ 3620' w/TOL @ 3371' (33' overlap into 7" shoe). RU Blue Jet Perf @4 spf @ 3438' to 3444', 3465' to 3477', 3492' to 3543'. Total of 276 shots. RD Blue Jet 8/30/06. RIH w/119 jts 2-7/8" tubing, 4.7#, J-55 tubing & landed at 3524', w/ FN @ 3523'. ND BOP, NU WH. RD release rig 8/31/06.


