Pumped preflush of 20 bbls fW & gel ahead of 530 sx (1366 cf - 243 bbls) Class G w/3% D-079; .2% D-046, .25#/sx D-029. Tailed w/270 sx (343 cf - 61 bbls) 50/50 G-POZ w/2% D-20, .1% D-46, 1% D-46, 1% S-001, 5#/sx D-24, .15% D-65. Dropped plug and displaced w/92 bbls FW. Bumped plug to 1600 psi. Circ. 80 bbls good cement to surface. RD cementers. ND BOP, cut off casing. Installed trash cap. RD & released rig 9/6/06. The casing PT will be conducted by the completion rig and results will be shown on the next report.
