Preflushed with 10/10/10 ahead of Scavenger 19 sx (56 cf - 10 bbls slurry) Class TYPE III. Lead 136 sx (290 cf - 51 bbls slurry) Premium Lite, TYPE III, CALC 3%, CELLOFLAKE 1/4, LCM 1 5 PPS, FL 52, SMS .04. Tail 90 sx (124 cf - 22 bbls slurry) TYPE 3, Class TYPE III, CALC 1%, CELLOFLAKE 1/4, FL 52 .2%. Dropped and displaced. Bumped plug and circ 8 bbls to surface. RD and released rig 0130 hr, 9/9/06.

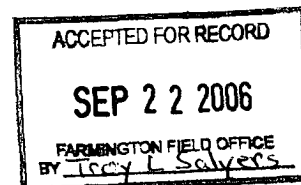
