Tail w/245 sx 50/50 POZ Type V w/0.5% Halad 9, 5#/sx flocele, 0.2% CFR-3 & 0.2% Super CBL. Circ. 143 sx to surface. Pressure test csg to 1000 psi - OK. TD reached 9/26/06.
