Cement second stage with 350 sks 65/35 Class B poz, 6% gel, 2% CaCl2 tailed by 145 sks Class G, 5#/sk gilsonite, 1/4#/sk flocele (866 cu.ft.). Circulate 60 bbls cement to surface. Plug down @ 8:00 pm on 09/24/06. WOC. RD Halliburton. Rig released. Will test production casing during completion.
