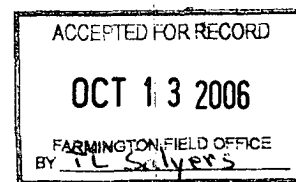

13. Describe Proposed or Completed Operations

3/19/06 MIRU Aztec #580. NU BOP, PT blind rams, valve & manifold - OK. PT casing to 600# / 30 min. OK. RIH w/6-1/4" bit & tagged cement @ 35'. D/O cement & drilled ahead to 2475' (TD). TD reached 3/20/06. Circ. Hole. RIH w/67 jts 4-1/2" 10.5#, J-55 casing and set @ 2473'. RU to cement. Pumped preflush of 10 bbls FW, 10 bbls gel ahead of 19 sx (27 cf - 10 bbls) Saavenger Premium Lite w/3% CaCl₂, .25#/sx Celloflake, 5#/sx LCM-1, .4% FL-52, .4% SMS. Lead w/206 sx (439 cf - 78 bbls) Premium Lite w/3% CaCl₂, .25#/sx Celloflake, 5#/sx LCM-1, .4% FL-52 & 4% SMS. Tailed w/90 sx (124 cf - 22 bbls) Type 3 w/1% CaCl & .25#/sx Celloflake. Dropped plug and displaced w/39 bbls FW. Plug down @ 2330 hrs 4/3/06 Circ. 36 bbls cement to surface. Back off landing jt. ND BOP, RD & released rig 3/21/06.
