Black Hills Gas Resources plans to set a blanking plug in the on/off tool above the PKR @ 3609'. This will isolate the FRTC and PC perfs below the PKR. We will then swab and/or pump test the existing Tertiary perfs above the PKR. If the Tertiary perfs prove to be productive, the Tertiary will be placed on line.
