Drilled 12 1/4" hole to 327' on 7/31/06, set 7 jts of 9 5/8", H-40, ST&C, 32.3# casing at 316'. Cemented w/200 sx (42 bbls) "G" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 18 bbls of cement to surface. Test casing to 2,000 psi.

Drilled 8 3/4" hole to 3,966' on 8/8/06, set 89 jts of 7", J-55 LT&C, 23# casing at 3,959'. Cemented lead w/750 sx (196 bbls) 50/50 POZ cement w/3% Gel, 5# Gilsonite, 1/4# Flocele, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (16 bbls) STD "B" cement w/0.4% Halad 344. Circulated 50 bbls of cement to surface. Tested casing to 1,500 psi.

Drilled 6 1/4" hole to 4,466' TVD on 8/20/06. Underreamed hole to 11" from 3,969' to 4,466'. Utilized natural and air assisted surges to remove near wellbore material. On 9/14/06, set 13 jts 5 1/2" 15.5, J-55 liner at 4,405' with liner hanger at 3,868'. Perforated liner with size 0.55" holes, 120" phasing, total of 448 holes from 4,027' to 4,353'. Landed 2 3/8" production tubing at 4,392'. (OK- 54 10/27)
