Drilled 12 1/4" hole to 298' on 7/24/06, set 9 jts of 9 5/8", H-40, ST&C, 32.3# casing at 292'. Cemented w/200 sx (42 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 15 bbls of cement to surface. Test casing to 1500 psi.

Drilled 8 3/4" hole to 3,625' on 7/29/06, set 81 jts of 7", J-55 LT&C, 23# casing at 3,620'. Cemented lead w/500 sx (127 bbls) 50/50 POZ w/3% Gel, 5# Gilsomite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344. No cement to surface, top of cement is at 730'. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 6,143' on 8/1/06, set 145 jts 4 1/2", J-55, LT&C, 11.6# casing at 6,143'. Cemented lead w/325 sx (88 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL. No cement to surface, top of cement is at 1,300'. Tested casing to 1500 psi. Landed 2 3/8" production tubing at 6,103'.
