Drilled 12 1/4" hole to 306' on 9/18/06, set 14 jts of 9 5/8", H-40, ST&C, 32.3# casing at 296'. Cemented w/150 sx (17 bbls) "B" cement w/2% CaCl and 1/4# PSX Floseal. Circulated 12 bbls of cement to surface. Test casing to 750 psi.

Drilled 8 3/4" hole to 4,070' on 10/20/06, set 94 jts of 7", J-55 LT&C, 23# casing at 4,059'. Cemented lead w/550 sx (142 bbls) 50/50 POZ w/3% Gel, 5# Gilsonite, 1/4# Flocele, 1/10% CFR 3, 4/10% Halad 344 and tail w/75 sx (19 bbls) same slurry non-foamed. Circulated 30 bbls of cement to surface. Tested casing to 1500 psi.

Drilled 6 1/4" hole to 8,518' on 10/29/06, set 203 jts 4 1/2", J-55, LT&C, 11.6# casing at 8,514'. Cemented lead w/260 sx (68 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/225 sx (56 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. No cement to surface, top of cement is at 1,000'. Tested casing to 1500 psi.
