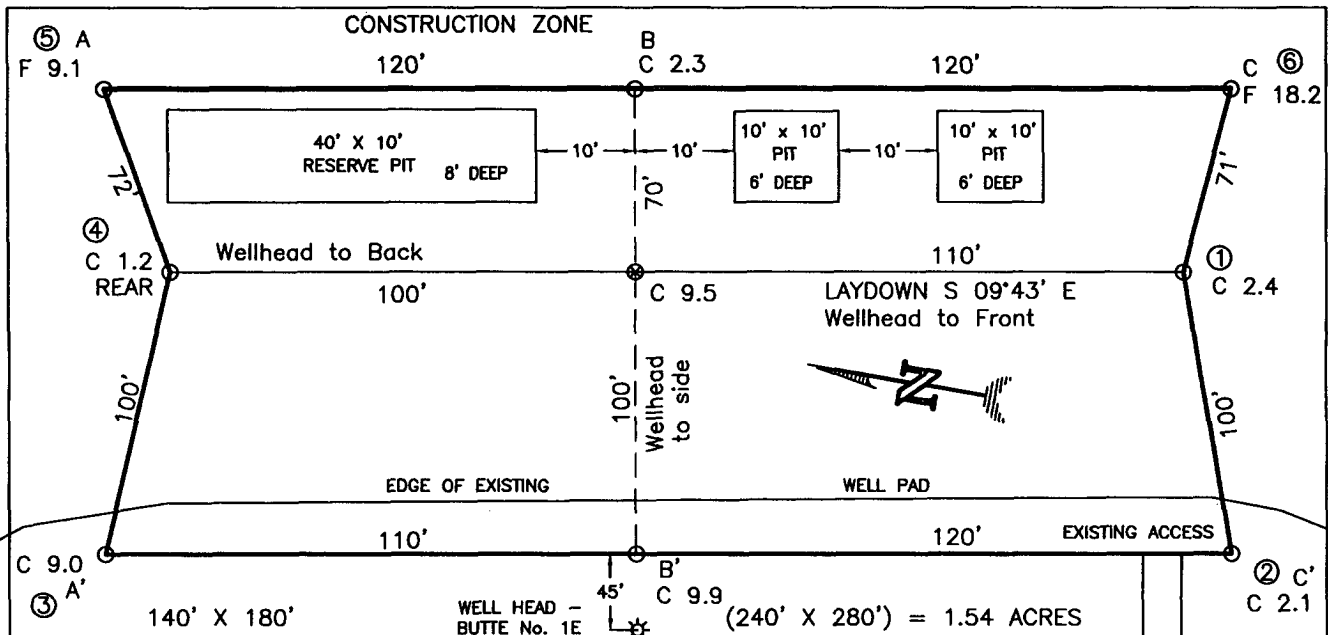

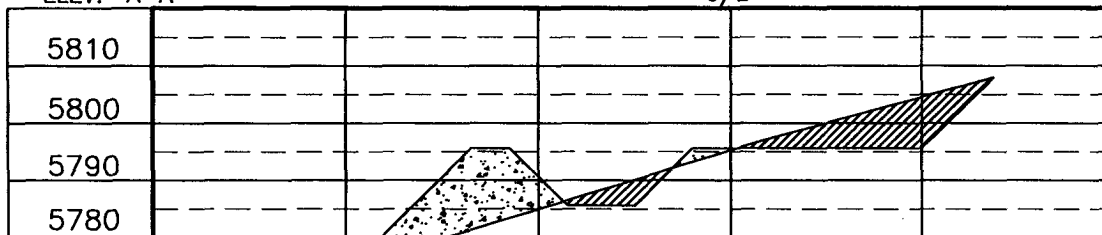

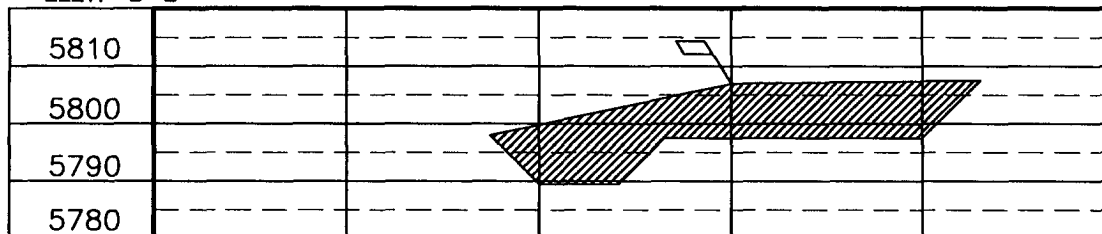

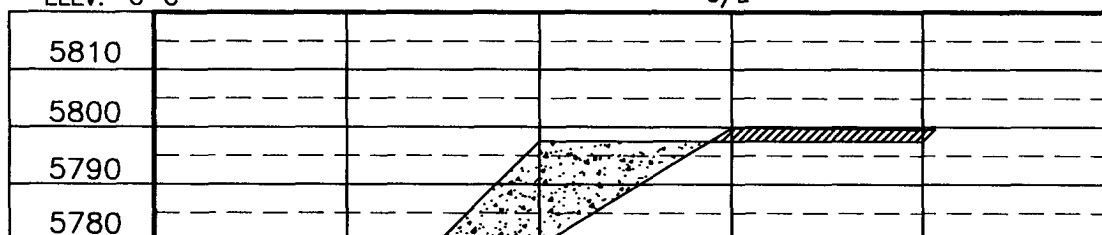
ELEV. A-A'
