As soon as pit is dried, Merrion Oil & Gas will begin the process of backfilling, leveling and contouring. The liner is to be cut off at mud level.

Waste disposal and spoils materials will be buried using stockpiled topsoil. The stockpiled soil material will be spread on the reclaimed portions of the pad, including the reserve pit, cut and fill slopes prior to re-seeding.
