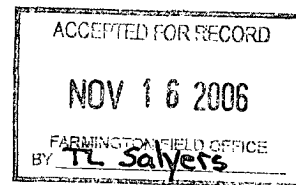

Drill to TD @ 1030' on 11/8/06. Run 5½" 15.5# J-55 csg in 7" hole. Land @ 1023', float collar @ 982'. Cement w/50 sx Type 5 cement w/2% Lodense w/3# PhenoSeal & 1/4# celloflake/sx. Tail w/50 sx Type 5 cement w/3# PhenoSeal & 1/4# celloflake/sx (170 cu ft total slurry). Displace w/23 bbls water. Circulate 8 bbls cement. Pressure test will be reported on completion sundry.
