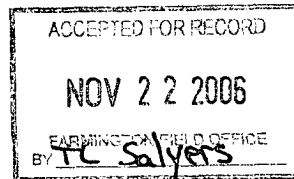

Drill to TD @ 900' on 10/5/06. Run 5 1/2" casing in 7" hole. Land @ 890', float collar @ 847'. Cement w/45 sx Type 5 cement w/2% Lodense w/3# PhenoSeal & 1/4# celloflake/sx. Tail w/50 sx Type 5 cement w/3# PhenoSeal & 1/4# celloflake/sx. Circulate 10 bbls cement. Pressure test will be reported on completion sundry.
