8/4/03 - Drilled 8 3/4" hole and ran 7", J-55 23# LTC casing and landed @ 3926' KB. KB = 13' 0"

Ran centralizers on the bottom 2 joints including shoe joint. Also ran 2 turbulizers at the base of the Ojo and one joint into the Ojo. DV tool set @ 3003'.

1st Stage- Cemented with 155 sks 50:50 Class G Poz at 13#, 2.5 lbs/sk phenosal, .25 lb/sk cello flake, 2% bentonite gel, 4% gilsonite, 1# sk CemNet, yield 1.45. 2nd Stage-Cemented with 360 sks of 9.5# LiteCrete, with 1# sk CemNet, yield 2.53. Circulated 23 bbls cement to surface. WOC cement 12 hours.

8/5/03 - Pressure tested casing to 1000 psi for 30 minutes. Held O.K. Test BOPs to 1000# held O.K. Tagged cement @ 3003' (DV Tool).
