Cmt'd w/465 sx Prem Lite cmt w/1% CaCl₂, 1/4 pps Celloflakes & 2% Phenoseal (11.93 ppg & 2.04 cuft/sx) f/b 100 sx Type III cmt w/1/4 pps Celloflakes (14.2 ppg & 1.46 cuft/sx). Lost circ. TOC 1254'. PT csg to 1200# for 30 min. Tstd OK.

Cmt'd w/140 sx Prem Lite FM cmt w/8% Bentonite, 2% CaCl₂, 1/4 pps Celloflakes, 0.4% Fluid Loss Control, 0.4% Sodium Silicate & 5% LCM 1 (12.1 ppg & 2.08 cuft/sx) f/b 130 sx Prem Lite cmt w/1/4 pps Celloflakes, 0.2% Cmt Dispersant, 0.5% Fluid Loss Control & 4% Phenoseal (12.5 ppg & 2.03 cuft/sx). Circulated w/no returns. TOC will be determined & reported when logs are run.
