XTO Energy Inc. spudded 12-1/4" surf hole @ 4:30 p.m., 10/23/06 and drilled to 232'. Ran 9-5/8", 36#, J-55 csg on 10/25/06 to 228' KB. Cmt w/125 sx Type III cmt w/3% CaCl & 1/4 pps Celloflakes (15.2 ppg & 1.28 cuft/sx). Circ 8 bbls good cmt to pit. Casing & shoe did not pass 750 psi test. Pressure up to 750 psi & bled off to psi in 5 min. Dumped 15 buckets sand down csg & tried again w/same results. Spoke to Jim Lovato @ BLM - said we will have to bring cmt to surf on intermediate job.

Drilled to 1994' and set 7", 20#, J-55 intermediate casing on 11/2/06 to 1982' KB. Cmt w/200 sx Prem Lite cmt w/1/2 pps Celloflakes, 0.5% FL-52, 2% Phenoseal & 2% KCl (12.1 ppg & 2.13 cuft/sx) f/b 100 sx Prem Lite cmt w/3% A-10, 1/4 pps Celloflakes, 0.2% FL-52 & 2% Phenoseal (12.5 ppg & 2.03 cuft/sx). Circ 50 bbls cmt to surf. PT 7" csg to 1500 psig f/30 min. Tstd OK.
