
XTO Energy Inc. spudded 12-1/4" hole @ 6:30 a.m., 10/13/06; drilled to 380' KB. Ran 8-5/8", 24#, J-55 casing to 377' KB. Cntd w/185 sx Type III cmt w/3% CaCl₂ & 1/4 pps Celloflakes (14.5 ppg & 1.42 cuft/sx). Circ 20 bbls cmt to surf. Pressure tested surf csg to 1000 psig for 30 min. Tstd OK.

Reached driller's TD of 6950' @ 5:45 a.m., 10/23/06.

Ran 5-1/2", 15.5#, J-55 casing to 6950' KB. Cntd 1st stage w/230 sx Prem Lite cmt w/0.2% CD-32, 1/2 pps Celloflakes, 0.5% FL-52, 2% KCl & 2% Phenoseal (12.5 ppg & 2.01 cuft/sx) f/b 150 sx Type III cmt w/0.3% CD-32, 1/4 pps Celloflakes & 0.2% FL-52 (14.6 ppg & 1.37 cuft/sx). Circ 26 bbls to surf. Cntd 2nd stage w/370 sx Type III cmt w/8% Bentonite & 1/4 pps Celloflakes (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx).

Production casing will be tested upon completion.
