XTO Energy Inc. spudded 12-1/4" hole @ 11:00 p.m., 9/24/06 and drilled to 380'. Ran 8-5/8", 24#, J-55 casing to 379'. Cmt'd w/250 sx Type III cmt w/3% CaCl₂ & 1/4 pps Celloflakes (14.5 ppg & 1.42 cuft/sx). Circ 21 bbls cmt to surf. Pressure tested surf casing to 1000 psig for 30 min.

Reached driller's TD of 7040' @ 11:00 p.m. 10/6/06.

Ran 5-1/2", 15.5#, J-55 casing in 7-7/8" hole to 7032' KB. Cmt'd 1st stage w/250 sx Prem Lite cmt w/0.2% CD-32, 1/2 pps Celloflakes, 0.5% FL-52 & 2% KCl (12.5 ppg & 2.01 cuft/sx) f/b 150 sx Type III cmt w/0.3% CD-32, 1/4 pps Celloflakes & 0.25% FL-52 (14.2 ppg & 1.48 cuft/sx). Maintained good circulation but no cement returned to surf. Cmt'd 2nd stage w/365 sx Type III cmt w/8% Bentonite & 1/4 pps Celloflakes (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type II neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 25 bbls cement to surface.
