1/24/05. MIRUSU. TOH with rods, pump & tbg. Ran Arrowset I packer on 2-3/8" 4.7# J-55 tbg & set packer @ 3605' with bottom of tbg @ 3614'. Swabbed well. Released rig on 1/28/05. Completed as a single PC producing up the tubing. The Tertiary is shut-in in the annulus.
