The S9 Fruitland Coal was perforated, acidized, and frac'd.

- The S9 Fruitland Coal was perforated from 502'-512' and 558'-565' Kb with 4 SPF, 0.42" diameter, and 120 degree phasing.
- 750 gallons of 15% HCl was pumped during acidizing.
- This zone was stimulated with 29,966 gallons of 20# Delta 140 cross linked gel and 96,500 pounds of 16/30 Ottawa sand.
