On 11/20/06, set 10 jts 5 1/2" 15.5, J-55 liner at 3,503' with liner hanger at 3,053'. Perforated liner with size 0.55" holes, 120° phasing, total of 468 holes from 3,159' to 3,423'. Ran in hole with 109 jts 2 3/8" tubing to 3,490'.
