This request is principally due to the recent Change of Operator and associated personnel changes resulting in delays to AFE, WIO and other necessary approvals as well as drilling schedules. These changes and delays will preclude our ability to drill this well prior to its APD expiration date of 1/24/2007.

Your approval of this 1 Year Extension, or until 1/24/2008, to the approved APD will be greatly appreciated and allow us the opportunity to continue pursuit of this new drill prospect. We currently anticipate mid to late year 2007 startup on this project.
