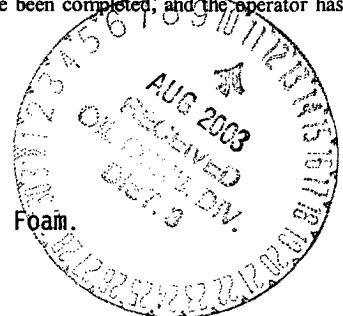

13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. It is intended to add the Menefee to the existing Mesaverde as follows:

1. MIRU. TOH with tubing.
2. Set CIBP @ 4450'. Pressure test casing to 3000 psi.
3. Selectively perforate the Menefee from 4079' - 4403'. Fracture treat with 60Q Foam.
4. Flow back well.
5. TIH, drill out CIBP and clean out to PBTD.
6. Land tubing @ 4756'. Return to production.
