## 13. Describe Proposed or Completed Operations

Due to this well being in an area where the Cliffhouse is wet, the 7" casing must be set deeper than originally proposed. The proposed depth of the 7" casing is 4355' (150' into the Menefee, top of Menefee at 4205').

The casing will include 405' of 7" 23#/ft, J-55 LTC on bottom in addition to the originally proposed 7" 20#/ft J-55 STC.

The cement volumes have been adjusted for the revised depth to be returned to surface.
