Install 4.50" cement head. Pumped 23 bbls. 50/50 Type V poz, 2% gel, 5#/sk gilsonite, 1/8#/sk flocele. No pressure. ND cement head. Fill casing with same to top of casing, adding 7 bbls. cement. Install P&A marker. RD. MOL.
