M & G Drilling Company, Inc. requests permission to change the hole size on this well from 6 1/4" to 7 7/8". We also propose to run 4 1/2" 10.5# casing as opposed to 4 1/2" 11.6# casing. The cement volumes will be increased to the following: 350 sx of lead cement containing 2% sodium metasilicate and 1/4 #/sk cello flakes followed by 100 sx of cement containing 2% CaCl and 1/4 #/sk cello flakes, for a total of 839 cf of cement.
