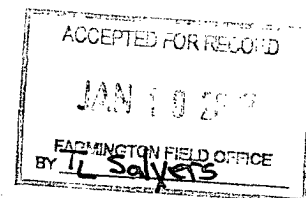

Cement with 80 sks 65/35 Class G poz, 6% gel, 10#/sk gilsonite, 1/4#/sk flocele tailed by 70 sks Class G, 5#/sk gilsonite, 1/4#/sk flocele (244 cu.ft.). Circulate 5 hbbs cement to surface. Plug down @ 4:50 pm on 12/18/06. RD Halliburton. Rig released. Will test production casing during completion.
