1/4/07 MIRU Patterson #747. Re-spud 12 1/4" @ 0700 hrs on 1/4/07. Drilled 300'. Circ hole. RIH w/ 6 jts, 9 5/8, 32.3#, H-40 ST&C casing set @ 280'. Preflush w/ 20 bbls FW. Pumped 300 sx (354 cf - 63 bbls slurry) class G cement w/ 2% Cacl2, 1/8#/sx pot-e-flake 5.2 gal/sk mix water. Dropped Plug and displaced w/ 20 bbls FW. Circ 15 bbls cement to surface. WOC. NU BOP. 1/9/07, PT Casing 1000 #/ 30min. Good test.
