Pumped Lead 67 sx (108 cf - 19 bbls) Type 1-11 w/ 20% Fly Ash. Dropped plug and displaced with 14 bbls FW. Circ 2 bbls cement to surface. WOC. Install WH. RDMO. The casing PT will be conducted by the drilling rig and results will be shown on the next report.
