This well was completed in the Fruitland Coal Formation 8/4/06, and SG is in the process of obtaining sales pipeline ROW's from BLM. Due to the length of time before we are able to put this well on line, SG is requesting approval to vent gas to the atmosphere for up to 30 days in order to evaluate anticipated production. Total volume vented will not be anything even close to 50 MMCF. Any produced water will be trucked to an approved disposal facility.
