12/26/06. Spud well. Drill 12-1/4" hole to 316'. Ran 8-5/8" 24# J-55 csg & set @ 316'. Cmt w/250 sks (295 cf) Type G cmt w/2% CaCl & 1/8# polyflake. Circ 8 bbls cmt to surface. Pressure test casing to 800 psi-OK.

Drill 7-7/8" hole to 3844'. 12/8/06: Ran 5-1/2" 15.5# J-55 casing & set @ 3844'. Cemented 1st stage with 625 sacks (1225 cf) Type G 65/35 POZ cmt w/6% gel, 10# gilsonite, & 1/4# polyflake. Tail with 175 sacks (256 cf) 50/50 POZ w/3% gel, 0.5% Halad 9, 5# gilsonite, & 1/8# polyflake. Circulated 40 bbls cement to pit. Pressue tested 5-1/2" csg to 1000 psi for 30 min - OK.
