Set 5-1/2", 15.5#, J-55 LT&C prod casing @ 7757' KB. Cmtd 1st stage w/449 sx Prem Lite cmt w/1/2 pps Celloflakes, 0.2% Cement Dispersant, 0.5% FL-52, 2% Phenoseal & 2% KCl (12.5 ppg & 2.01 cuft/sx) f/b 150 sx Type III cmt w/1/4 pps Celloflakes, 0.3% Cement Dispersant, 0.2% FL-52, 2% Phenoseal & 0.2% Retarder (14.2 ppg & 1.54 cuft/sx). Circ 40 bbls cmt to surf. Cmtd 2nd stage w/471 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflakes & 2% Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 175 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 50 bbls cmt to surf.
