Pressure tested 7" csg to 2000 psi for 30 min. - OK. Retrieved RBP @ 6534' & TOH. Ran temp survey from liner top (6542') to PBTD. Temp survey indicated that liner hanger is leaking. Ran deviation surveys @ 7970' & 6560'. Perfed 4-0.75" holes @ 7969'. Set 7" Arrowset 10K pkr @ 6504' w/tail pipe to 6532' & on/off tool above pkr. Tested Mancos on 1/19/07 for 2 hrs on 1/2" choke for 420 psi & 2721 MCF/D. Landed 2-7/8" 6.5# J-55 tbg in on/off tool @ 6503". Released rig on 1/24/07. Completed as a single WC Basin Mancos gas well.
