XTO Energy Inc. requests approval for an exception to NMOCD Rule 303-C to permit DHC of production from the Basin Dakota & the Gallegos Gallup in the Gallegos #4E. The proposed allocations are based upon average production of this well and are as follows:

Basin Dakota	Gas: 39%	Oil: 11%	Water: 40%
Gallegos Gallup	Gas: 61%	Oil: 89%	Water: 60%

Both pools are included in the NMOCD pre-approved pool combinations for DHC in the San Juan Basin. Interest owners were common; therefore, no notice to owners was necessary. The NMOCD has been notified of our intent by submission of a C-103. Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights.
