csg @ 236' w/150 sx Type III cmt w/3% CaCl2 & 1/4 pps Celloflakes (14.5 ppg & 1.42 cuft/sx). Circulated  
10 bbls cmt to surf. Press tstd csg to 1000 psig for 30 min. Tstd OK.

Drilled 7-7/8" hole to 1520' (TD) on 12/30/06.

Ran 5-1/2", 17#, J-55 casing to 1518' KB. Cmt w/124 sx Prem Lite cmt w/2% CaCl2, 0.2% CD-32, 1/4 pps  
Celloflakes, 0.5% FL-52 & 2% Phenoseal (12.5 ppg & 2 cuft/sx) f/b 100 sx Type III cmt w/0.3% CD-32, 1/4  
pps Celloflakes, 0.2% FL-52 & 2% Phenoseal (14.2 ppg & 1.48 cuft/sx). Circ 15 bbls cmt to surf.
