01/05/07 spud 8-3/4" surface hole. Drilled to 147' KB. Ran 3 jts (136.34') of 7", 20#, J-55, ST&C new casing and set casing at 141' KB. Cemented with 65 sx (77 cu.ft.) of Type 5 with 3% CaCl<sub>2</sub> and 1/4 #/sk celloflake. Circulated 5.0 bbls of good cement to surface.

01/07/07 Nipped up the BOP and pressure tested the casing and BOP to 1000 psi.

01/08/07 TD 6-1/4" hole at 1806' <sup>8 per Gwen</sup> Ran 41 jts (1803.21') of 4-1/2", 10.5#, J-55, ST&C production casing and landed at 1808' KB. Insert float is at 1788' KB. Top of marker joint is at 1316' KB. Cemented with 150 sx (309 cu.ft.) of Type 5, 2% sodium metasilicate, 1/4 #/sk celloflake, followed by 75 sx (89 cu.ft.) of Type 5, with 1/4 # celloflake. Bumped plug to 1500 psi. Top of cement was 893'. Released Rig on 01/09/07.
