BP America requested permission to drill above mentioned well on 6/21/04 and approval was granted 8/17/04.

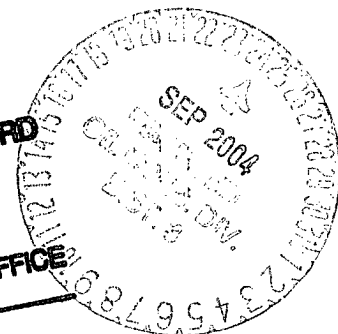
