13. Describe Proposed or Completed Operations

Golden Oil repaired the 4.5" casing in this well per the following from 1/03/07 to 1/18/07:

MOL and RU. Pull rods, found tubing stuck. Free point and cut tubing at 6037'. Fish out packer and tail pipe. Set RBP at 6001'. Isolate casing leak from 4911'-5000'. Advised B. Hammond with JAT about cementing. Squeeze casing leak with 260 sxs Type III (343 cf) cement, final 1500 PSI. Drill out cement from 4735' to 4965'. Pressure test casing to 750 PSI for 15 minutes. Ran casing scraper to 5965'. TIH with retrieving head and pull RBP. Land 231 joints 2.375" tubing at 7258' KB, with 1 joint tail pipe, 4' perfed sub and then SN at 7220' KB. Ran 2" X 1-1/4" x 14' RHAC pump and 195 -3/4" rods and 92 - 7/8" rods; spaced out and hung on head. Pressure test tubing to 300#, held OK. RD and MOL
