Ran total of 6 joints with 28 preperfed 0.5" holes in each. Top of the bottom preperfed joint is @ 7151' w/bull plug on bottom. The other 5 preperfed joints are plugged and have tops @ 6646', 6136', 5627', 5120', & 4608'. Released drilling rig on 1/16/07. Waiting on completion rig.
