Noise-log reflected channeling behind the production casing but no indication of holes. Plan to run a cement bond log, perforate & cement-squeeze to shut-off the channeling. Plan to pressure-test the production casing throughout the entire wellbore. Any holes in the casing will be cement-squeezed as necessary. A detailed procedure will be submitted by 3/1/07.
